SSC CGL Income Tax Inspector Syllabus for Tier 1: Quantitative Aptitude

The Quantitative aptitude section tests Quantitative skills along with logical and analytical skills of the candidates. The questions in the quants paper will be designed to assess candidates' ability to appropriately use numbers and number sense of the candidate. It will test the sense of order among numbers, ability to translate from one name to another, sense or order of magnitude, estimation or prediction of the outcome of order computation, selection of an appropriate operation for the solution of real-life problems, and knowledge of alternative computation procedures to find answers. The questions would also be based on arithmetical concepts and relationships between numbers and not on complicated arithmetical computation (The standard of the questions will be of 10+2 level).
