Interested and eligible candidates may attend the written screening test followed by an interview (for the shortlisted candidates) in the **MPH hall 2, Dept. of Preventive and Social Medicine, II Floor, JISPH Building, JIPMER**. Details are attached in Annexure 1. The applicants are requested to bring the filled-in application form (Annexure 2) and bio-data with self-attested copies of testimonials with original certificates for verification.

NOTE:

1. Validity of the shortlist will be for one year from the publication date of the result and renewable accordingly.
2. Qualification and experience should be in a relevant discipline/field and from an institute of repute. Experience should have been gained after acquiring the minimum essential qualification.
3. Qualification, experience, and other terms and conditions may be relaxed/ altered at the discretion of the Project Investigator.
4. The upper age limit may be relaxed per Govt. of India rules.
5. The posts are purely on a contract basis for an externally sponsored project, and no claim for any other regular post in JIPMER shall be entertained.
6. Selected candidates may have to go to the field (rural and urban areas), carry out health awareness programs, coordinate meetings with local leaders, collect blood from the field early morning and late evening, process the sample, and store it appropriately, send emails and coordinate with the project team.
7. Valid email id and mobile number are compulsory.
8. The consolidated salary of the post may vary from time to time. No other allowance/ facilities other than consolidated salary shall be extended.
9. The decision of the Principal Investigator will be final.
10. No TA/ DA will be paid for the interview.
11. Canvassing of any kind will lead to disqualification.
12. Submission of wrong or false information during the selection process shall disqualify the candidature at any stage.
13. If the investigator finds the appointee's performance unsatisfactory, appointments can be terminated at any time without any notice.

14. The appointee may be relieved from the current position with one-month prior notice; failing to do so may be held responsible for paying one month's salary.
