UGC 2018 QUALIFICATION AND OTHER INFORMATION:

I. Eligibility (A or B): At the level of Assistant Professor:

A.

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D degree of the candidate has been awarded in a regular mode;
- b) The Ph.D thesis has been evaluated by at least two external examiners;
- c) An open Ph.D viva voice of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR /CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

B. The Ph.D degree has been obtained from a foreign University/Institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for Universities and Appendix (Table 3B) for Colleges, shall be considered for short-listing of the candidates for interview only and the selections shall be based only on the performance in the interview.

- (1) A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer) / Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- (3.5) A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
- (3.6) A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- (3.10) The Ph.D. Degree shall be a mandatory qualification for direct recruitment to the post of Assistant Professor in Universities with effect from 01.07.2021.
- III. Consolidated Remuneration: Rs.30,000/- per month
- **IV.** Nature of appointment: The appointment is purely temporary basis for a period of 11 months (initially four months and extendable for further seven months) or until the appointment of permanent faculty whichever is earlier.
- **V. Selection:** Candidates will be shortlisted based on their academic credentials and UGC norms. Only short listed candidates will be called for interview.
- 1. The selected candidates will be required to join immediately.
- 2. Canvassing in any form will render a candidate ineligible.
- 3. The University reserves the right to cancel the recruitment process of temporary faculty in partial or full without assigning any reasons whatsoever.
- 4. This appointment does not confer any right on the applicant to claim either continuous employment or permanency in future
- 5. Incomplete applications/ applications not in the prescribed format will be rejected without intimation.
- 6. No interim correspondence will be entertained.
- 7. The University reserves the right to shortlist the number of candidates depending upon the number of applications received or the qualifications of the applicants. No separate intimation will be made to the candidates who are not shortlisted. The decision of the Scrutiny / Selection Committee is final.
- 8. The applicants are requested to view the website of the University daily for any updated information regarding the recruitment process. List of candidates shortlisted for interview will be uploaded in the University Website. Separate communication for the candidates will not be sent.
- 9. University will not be responsible for any postal delay or loss of application during transit.
- 10. The number of vacancies indicated in the advertisement is tentative and subject to change. University reserves the right to change the number of positions based on the requirement.

 - c. Other academic distinctions, publications, if any;
 - d. Present occupation and salary with scale of pay;
 - e. Languages with which the applicant is conversant together with copies of recent testimonials;
 - f. Name of two persons to whom a reference can be made.
 [Candidates are advised to take Xerox copy of the application form.
 Self-designed application formats shall not be entertained]
- 3. Applications from candidates, who are in service, shall be sent through proper channel. If they anticipate any delay, they may send **one copy** in advance to the Registrar. However, their applications will be considered and they will be called for interview only if their applications forwarded through proper channel are received in time.
