GENERAL CONDITIONS/INSTRUCTIONS

- 01. The position of Research Scientist will be purely on contract basis for a period of 3 years and are not entitled for annual increment.
- 02. The position of Project Associate-I is initially for a period of one year and is renewable every year (upto March 2026 only) subject to satisfactory progress of work.
- 03. THOSE WHO POSSESS THE REQUIRED QUALIFICATION AS ON THE LAST DATE OF APPLICATION ONLY NEED TO APPLY.
- 04. AGE LIMIT (as on 06.05.2024) and Pay & allowances:

Minimum age is 18 years for all posts as on 06.05.2024.

Ex-Servicemen, Meritorious Sportspersons & Persons with Benchmark Disabilities (PWBD) are eligible for age relaxation as per Government of India Orders.

- 05. At present the place of posting is VSSC, Thiruvananthapuram, but the selected candidates are liable to be posted in any of the Units of the Indian Space Research Organisation/Department of Space situated anywhere in India as and when required.
- 06.The Organisation provides medical facilities (Contributory Health Service Scheme) for self [for Research Scientist only], free transport facilities, subsidised canteen facilities and housing accommodation subject to availability,
- 07. Candidates will have to produce the proof of the details furnished in their applications submitted on-line as and when required.

08. SELECTION PROCESS:

I. Research Scientist:

- **a.** All valid applicants will be called for written test. The written test Centre will be in Thiruvananthapuram only.
- b. Question paper pattern for written test
 - **Part 'A'** (Objective type) Area/Discipline Specific part Consists of 80 Multiple Choice Questions (MCQs) of 1 mark each (+1 and -1/3 pattern of marking) 90 minutes duration.
 - **Part 'B'** (Objective type) Aptitude/Ability Tests Consists of maximum 15 Multiple Choice Questions (MCQs) totaling to 20 marks (No negative marks) 30 minutes duration [Questions will be based on Numerical Reasoning, Logical Reasoning, Diagrammatic Reasoning, Abstract Reasoning & Deductive Reasoning].
- **c.** Interview: Based on performance in the written test, candidates will be short-listed for interview in the ratio of 1:5.
- **d.** Qualifying Criteria: Written test 50% each in Part 'A' & 'B', Interview 50 marks (Out of 100), Aggregate marks 60%
- **e.** Weightage in Panel Generation For generation of final panel, 50% weightage will be given to Written Test marks and 50% weightage to interview marks

Candidates called for Written Test will have the option to answer the questions in Hindi also. Please note that the qualification prescribed above is the minimum requirement and the same does not automatically make the candidates eligible for written test.

- II.Project Associate-I: Based on the online application, initial screening/written test will be conducted for shortlisting the candidates for interview. Candidates, if called for Written Test, will have the option to answer the questions in Hindi also. If written test is opted for preliminary screening, the written test score will not reflect in the final selection process. The final selection will be based on performance of candidates in the interview only. Please note that the qualification prescribed above is the minimum requirement and the same does not automatically make candidates eligible for written test/interview.
- 09. The Centre reserves the right not to fill up any of the vacancies, if it so decides.
- 10. Only Indian Nationals need apply.
- 11. No interim correspondence will be entertained.
- 12. Canvassing in any form will be a disqualification.
- 13. Candidates working under Central/State Government, Public Sector Undertakings, Autonomous bodies etc. should submit their application through proper channel or submit 'No objection certificate' at the time of interview.
- 14. Candidates possessing Degrees awarded by foreign universities should produce the equivalency certificate issued by Association of Indian Universities (AIU), New Delhi, at the time of interview.
